The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,717.7 million square meter equivalents (MSME) in August 2024, an increase of 12.9 percent compared to August 2023. Imports of textiles were 7,212.6 MSME in August 2024, up 17.5 percent from August 2023. Imports of apparel were 2,505.1 MSME in August 2024, up 1.4 percent from August 2023.

Imports of textiles and apparel were 66,428.4 MSME for the year-to-date August 2024, an increase of 6.7 percent from year-to-date August 2023. Imports of textiles were 49,712.4 MSME for the year-to-date August 2024, an increase of 8.6 percent from the year-to-date August 2023. Apparel imports for the year-to-date August 2024 were 16,715.9 MSME, up 1.4 percent from the year-to-date August 2023.
