The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,127.4 million square meter equivalents (MSME) in December 2024, an increase of 32.2 percent compared to December 2023. Imports of textiles were 7,078.0 MSME in December 2024, up 38.6 percent from December 2023. Imports of apparel were 2,049.4 MSME in December 2024, up 14.0 percent from December 2023.

Imports of textiles and apparel were 106,636.8 MSME for the year-to-date December 2024, an increase of 15.2 percent from year-to-date December 2023. Imports of textiles were 80,870.6 MSME for the year-to-date December 2024, an increase of 18.5 percent from the year-to-date December 2023. Apparel imports for the year-to-date December 2024 were 25,766.2 SME, up 6.0 percent from the year-to-date December 2023.
