The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,190.7 million square meter equivalents (MSME) in February 2025, an increase of 10.2 percent compared to February 2024. Imports of textiles were 6,117.4 MSME in February 2025, up 13.5 percent from February 2024. Imports of apparel were 2,073.2 MSME in February 2025, up 1.5 percent from February 2024.

Imports of textiles and apparel were 16,753.7 MSME for the year-to-date February 2025, an increase of 18.5 percent from year-to-date February 2024. Imports of textiles were 12,332.3 MSME for the year-to-date February 2025, an increase of 22.0 percent from the year-to-date February 2024. Apparel imports for the year-to-date February 2025 were 4,421.5 SME, up 9.8 percent from the year-to-date February 2024.
